

1. Notarial Instrument - sasine granted to Nicolas Watson of eighth part of lands of Coutpauld, following on charter by Abbot of Kintross, 1574 (SKO catalogue no 94).
2. Contemporary copy of special retour of Alexander Watson as heir to his father, Thomas Watson, portener of Coutpauld, in lands of Coutpauld, 1596. (SKO catalogue no 130).
3. Charter: Charles I to James Falconer and his wife, Janete Dugall, of the lands of the eighth part of the town and lands of Coutpauld, 1632.
4. Procurator of resignation by James Falconer of the two eighth parts of the town and lands of Coutpauld, 22 Nov 1632.
5. Instrument of resignation in favour of James Falconer and his spouse of the two eighth parts of the town and lands of Coutpauld, 23 March 1633

8. Decreet Absolut: Francis Brodie of Balivat against John Weymes of Bogie and Robert Gray, 1663.
9. Instrument of resignation and sasine of 4 ploughs of the land of Coutpauld by Alexander Falconer of Coutpauld in favour of William Brodie, 1677
