GENEALOGY 1777 - 1779

1. "Of the Family of Calder" - history of the family from the time of Macbeth, transcribed from Nisbet's Heraldry.
Copy is attested by Bp Hay 1777.
2. "Genealogy and descent of the Calders of Asswany and Muirtown from the Thains of Calder" 1799.
